Digging Peanuts & Frost

Just one or two days of temperature below 50 degrees F will usually result in the peanut plants inability to continue to mature. As such, waiting to dig to allow further maturity is no longer a primary consideration. Now priority should focus on the probability of frost. It is best to allow 72 or more hours between a digging and a frost. Refer to Peanut Notes No. 234 2023 for updated information.

UMO AgPrime Grants

University of Mount Olive AgPrime provides grants to North Carolina farmers for new and innovative agricultural project ideas that will increase farm profits. This grant program, which is supported by the North Carolina Tobacco Trust Fund Commission, was designed to strengthen farms and communities that were negatively impacted by the downturn of the tobacco economy. Grants up to \$10,000 are available. Priority will be given to applicants that meet all or most of the criteria below:

- Benefits current or past tobacco growers
- Increase income
- Will increase or maintain employment opportunities
- Has been adequately researched
- Is realistic and budgeted appropriately
- Shows that the applicant has the skills to complete the project
- Demonstrated or identified technical assistance to help them implement a successful project
- Presents a new direction or innovative opportunity to diversify, expand or implement new entrepreneurial plans for their farm operations
- Will become self-supporting or enhance your ability to keep farming
- Maintains or increases the number of acres used for production

NC Farm School 2024

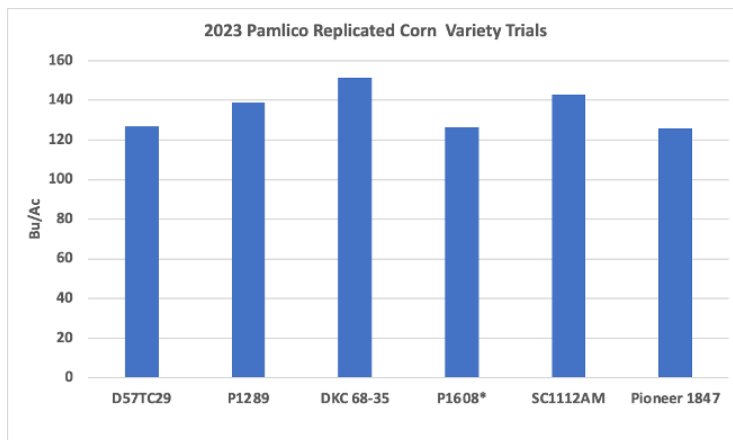
Anyone that has resources to begin an agricultural venture but has not yet developed a business plan or is seeking other alternative production systems to consider, should apply to attend the NC Farm School. This school will help one develop a written farm plan, provide access to one-on-one consultations, introduce participants to a network of experienced Extension Agents, reveal key resources, and engage folks into a network of other established farmers. Cost of the program is \$300 per person or \$550 per double registration.

Classroom sessions will be held at the Johnston County Extension Center from 6 pm - 9 pm on February 12th and 26th; March 11th and 25th; April 8th and 22nd; May 6th and 21st. Snacks, drinks, course material, and online resources will be provided.

Field Tours will be from 8:30 am.- 3 pm., with lunch provided, on February 21st: Wayne County; March 20th: Lee County; April 17th: Harnett County; May 15th: Wilson County; and May 29th: Johnston County.

Corn Variety Trial Data

Each year, NC Cooperative Extension Agents across the Southeast District plant corn variety trials to compare results of the same varieties within various yield and climatic environments. This year's trials were replicated to provide better results. Below are results from Pamlico, shared by Daniel Simpson, CED in Pamlico. Other counties performing the same test will be combined with this data for analysis. Until then note a few observations worth mentioning. First, the average for all varieties was 135 bu/ac. This is very much in line with what most corn growers relay to us within the area. Secondly, yield is a bit lower than normal for Pamlico due to the adverse heat and the long, dry period. Lastly, this site is simply one site's data. Other places of production within the area that were irrigated or had a timely rain or two resulted in much higher yield. Even so, the 134-145 bu/ac is probably a good average for corn within this portion of Eastern NC.

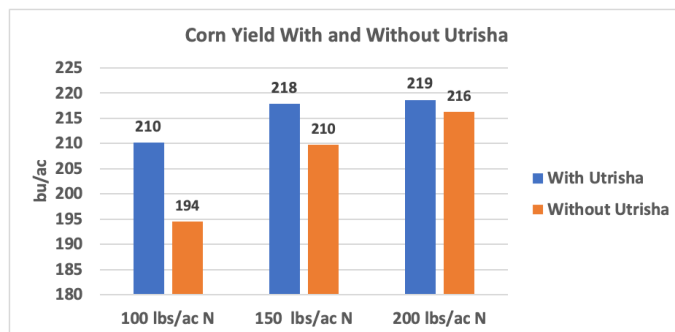

Utrisha-N Trials

Over the years we've been working with growers to apply Utrisha N (Corteva's product) to corn as a potential yield enhancement. Trials last year showed about 8-10 bu/ac advantage when 150 lbs./ac of N or less was applied. This year's replicated trial data is below. Note that as in years past, the greater yield increase from addition of Utrisha N resulted from the lower N rates. This matches essentially what we might expect from a biological product that increases a plants ability to utilize N. In other words, when excessive amounts of N are already being applied, there is little need to apply a product for more N uptake. There is way too much already applied!

The other interesting fact about these trials is that we consistently show that optimum and maximum economic N rate is between 100-150 lbs./ac. Anything else above this may slightly increase yield but is not profitable. If you don't like this data, sorry. We can't alter facts. Are there exceptions? Always! However, whether we place these test on sandy soils, heavy mineral soils, or organic soils, it seems that we tend to have optimum yield very near the NC RYE recommendations.

Common Questions Regarding Pesticide Licenses

The NCDA & CS Pesticide Division administers pesticide license and fees. NC State University and NC Cooperative Extension are not affiliated with this division other than having a great, cooperative working relationship! As such, if you have problems or concerns with your pesticide license, the best action is to contact this division at 919-733-3556. Below are some common questions we have received lately.

Question: When will I get my license renewal notification?

Answer: Normally the NCDA & CS Pesticide Division mails information regarding pesticide licenses in July and again in December. It is up to the individual to make a payment. Payments can be made any time one wishes to make a payment via their webpage or mail.

Question: How many hours do I have?

Answer: Again, we do not administer this information. A webpage has been designed to provide this information but it requires one to set up an account and log in to obtain this information. Each person must do this on their own. NC Cooperative Extension does not have such records.

Question: Why can't you look up my hours for me?

Answer: There are many reasons this does not happen. First, as noted above, it requires login information. Since computers automatically record personal data and login information for re-use, we must be careful to ensure our systems do not inadvertently acquire and store anyone else's personal data. We go to extremes to do such! Secondly, there are over 50,000 individuals within NC that have such a license. Our mandate states that should we provide a service or educational event, we offer it to everyone. We simply lack time and other resources to provide over 50,000 people with their current credit hours. Lastly, there may be (and almost always seems to be) some discrepancy regarding your records and what is online. As such, each individual must clarify this information on their own. We cannot do this for you.

Question: Why can't I find classes that I need?

Answer: There may be multiple reasons for this. The first is that you may be looking for a specific category within months that there are no such classes available. A great example is that Category V, Safety Classes, must be credited by the end of September each year. As such, there are rarely any Category V classes between October and December. Another reason is that now that online classes and fee-based classes are available almost upon demand, fewer face to face classes are provided. Lastly, as always, we humans make mistakes! Check to make sure you did not set the wrong criteria used to sort classes. Check the criteria and run the query again. If you get the same results, contact the NCDA & CS Pesticide Division. They may have made an error during entry.

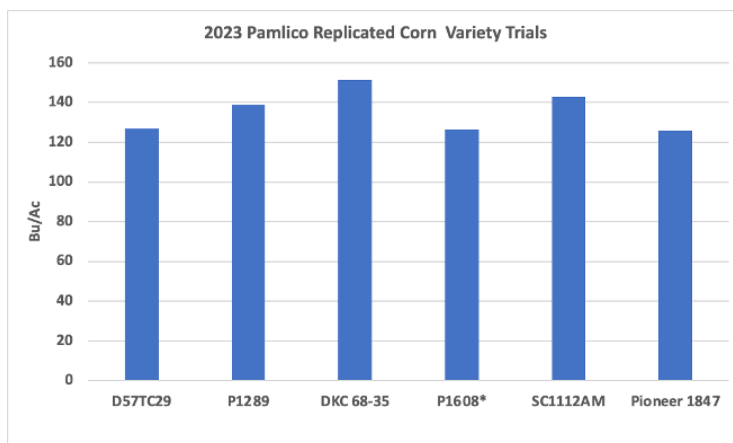

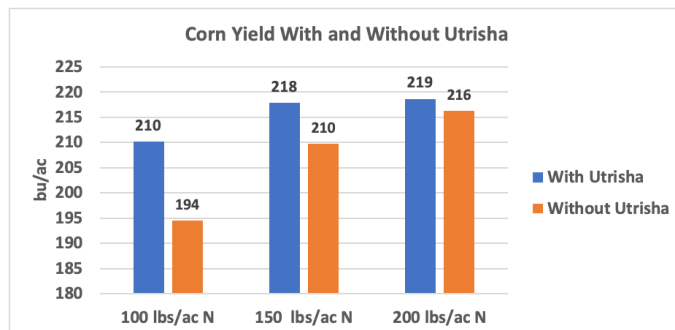
